

Casambi Warranty

Limited Warranty

Casambi warrants that its Products shall conform in all material respects to the technical specifications as set out at [Casambi.com \(https://casambi.com/products.html\)](https://casambi.com/products.html) under normal use and service for a period of sixty (60) months from the date of delivery. Deviations from published specifications which do not materially affect performance of the Products covered hereby shall not be deemed to constitute defects of material or workmanship or a failure of the Products to comply with such specifications. Casambi shall have the right to modify the technical specifications in its sole discretion. The terms of this warranty do not apply to any specification required by Buyer or any Product which has been subject to misuse or neglect, or damaged by accident (including fall, fire, exposure to water and abnormal electrical exposure), that has been modified by anyone without Casambi's authorization. The warranties contained herein shall extend only to Buyer and shall not apply to Buyer's affiliates or customers. Buyer shall return defective Products at its own expense to Casambi. Casambi's sole and exclusive obligation, and Buyer's sole and exclusive remedy for the defective Products shall be limited to the replacement of the defective Products within a reasonable period of time after their receipt by Casambi from Buyer, in accordance with the term of delivery under the Agreement or these General Terms and Conditions.

BUYER ACKNOWLEDGES AND AGREES THAT THE PROVISIONS CONTAINED IN THIS WARRANTY CONSTITUTE THE SOLE AND EXCLUSIVE REMEDY AVAILABLE TO IT WITH REGARD TO THE PRODUCTS. EXCEPT FOR THE EXPRESS WARRANTIES MADE IN THIS SECTION, CASAMBI EXPRESSLY DISCLAIMS AND EXCLUDES ALL ADDITIONAL OR OTHER WARRANTIES AND REPRESENTATIONS, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING ALL WARRANTIES WHICH, BUT FOR THIS PROVISION, MIGHT ARISE FROM COURSE OF DEALING, CUSTOM OR TRADE AND INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR PARTICULAR PURPOSES AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS WITH RESPECT TO THE PRODUCTS FURNISHED BY CASAMBI HEREUNDER. Certain jurisdictions do not permit the disclaimer of certain warranties, so this limitation may not apply to Buyer.

Buyer shall ensure that any Products are used in compliance with all requirements and standards imposed by any applicable rules, regulations and guidelines including without limitation any requirements and standards regarding instructions for use of the Products and manuals. Casambi expressly disclaims that the Products fulfill any requirements or standards, other than those set out in applicable laws (such as CE marking laws), standards, codes, rules and regulations, and safety approvals, as defined from time to time in the Products technical specifications. Notwithstanding the foregoing, if Buyer intentionally orders Products with specifications that do not fulfill some or all of the requirements and standards in force in the European Community, Casambi expressly disclaims any liability for conformance of such Products with the requirements and standards in force in any jurisdiction.

Limitation of Liability

IN NO EVENT SHALL CASAMBI BE LIABLE FOR ANY LOST PROFITS, LOSS OF BUSINESS, CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, PUNITIVE, SPECIAL OR OTHER DAMAGES WHATSOEVER RESULTING FROM CASAMBI'S PERFORMANCE OR FAILURE TO PERFORM UNDER THE AGREEMENT OR THESE GENERAL TERMS AND CONDITIONS OR THE FURNISHING, PERFORMANCE OR USE OF ANY PRODUCTS SOLD PURSUANT HERETO, WHETHER DUE TO BREACH OF CONTRACT, BREACH OF WARRANTY, STRICT LIABILITY, PRODUCT LIABILITY, NEGLIGENCE OF CASAMBI OR OTHERWISE. The maximum total liability of Casambi under the Agreement and the General Terms and Conditions of whatever nature and for any and all causes shall be limited to EUR 50,000.00. THE DAMAGE LIMITATIONS PROVIDED HEREIN AND THE REMEDIES STATED HEREIN SHALL BE EXCLUSIVE AND SHALL BE BUYER'S SOLE REMEDY. THIS LIMITATION ON LIABILITY SHALL SURVIVE FAILURE OF ANY ESSENTIAL PURPOSE.
